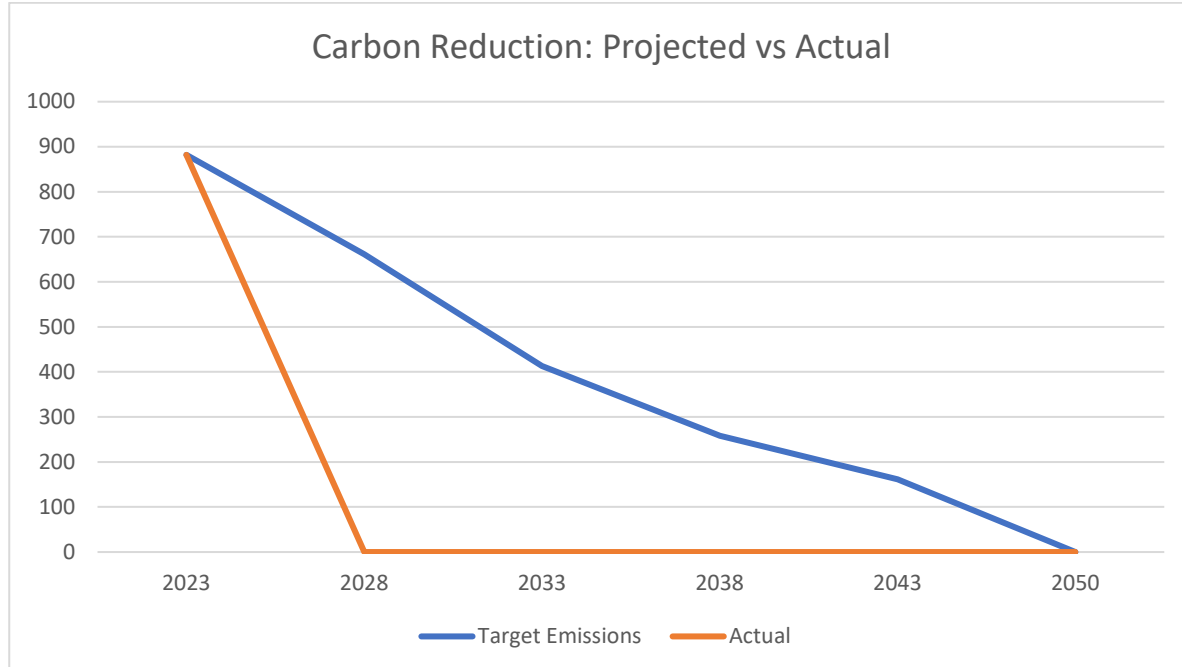

Emissions reduction targets

In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets.

We project that carbon emissions will decrease over the next five years to **661.42 tCO₂e by 2028**. This is a reduction of **25%**

Completed Carbon Reduction Initiatives

The following environmental management measures and projects have been completed or implemented since the 2023 baseline, and the measures will be in effect when performing the contract.

- Convert 25% of our Fleet to Electric Vehicles
- Supplied equipment with water recycling technology and lithium-ion batteries
- Maintain ISO14001 and Ecovadis accreditation
- Continue to review Scheduling process to ensure Field Teams planned routes are as efficient as possible

In the future we hope to implement further measures such as

- Convert a further 25% of our Fleet to electric vehicles
- Packaging usage with suppliers
